

## IFA T&C's

### **General**

The terms and conditions below apply to all aspects of ifa-berlin.com (the "Site") and IFA (the "Event") including but not limited to registration and purchase of tickets for the Event and any other event organized by IFA Management GmbH ("IFAM"). Before completing your registration or purchasing your tickets with the Site or for the Event we ask that you read the terms and conditions set out below.

The Site and Event are owned by IFAM, which is a part of the Clarion Events group.

The applicability of any of your purchasing or other general terms and conditions is expressly rejected, unless agreed otherwise by IFAM in writing. By purchasing a ticket or registering for the Event you agree to comply with and be bound by these terms and conditions. These terms may be amended without notice to you. Your continued use of the Site and other IFA products or attendance at the Event will mean that you accept these changes.

### **Solicitation and Advice**

The Site does not constitute a solicitation to buy or sell any investment. No information contained in the Site or provided at the Event should be deemed to constitute the provision of financial, investment or other professional advice in any way.

### **Content of the Site and the Event**

By proceeding you agree to the exclusion by us of any liability, including without limitation that arising from any loss of profit or any other damage direct or consequential, in respect of any errors and/or omissions by us and/or any relevant third parties in respect of the content of the Site.

The contents of the Site and the Event are based upon sources of information believed to be reliable, however, save to the extent required by applicable law or regulations, no guarantee, warranty or representation (express or implied) is given as to its accuracy or completeness and IFAM and the Clarion Events group and each of their respective members, officers and employees do not accept any liability or responsibility in respect of the information or any views expressed herein.

If you have accessed the Site using a link from another site, IFAM does not accept any liability or responsibility for the accuracy of information contained within the sites of other providers who have links to any pages of this Site or to whom this Site is linked.

### **Registration and payment**

By submitting registration details, you are agreeing to allow IFAM to contact you as required for the organisation and administration of the Event. If IFAM cannot reach you

and thus cannot verify the data entered by you upon registration, IFAM may cancel the order.

The prices for a ticket are listed on the Site and such prices are subject to German value added tax at 19% or, if different, the prevailing rate from time to time.

### **Notification**

You agree to notify us of any changes to your personal circumstances with respect to any information or representation made herein and to provide us with any changes to this information as we may reasonably require.

### **Ownership and Copyright**

The copyright in the Site and the Event (unless otherwise indicated), its contents, including all information, graphics, code, text and design are owned by IFAM and should not be reproduced or distributed without permission.

### **Admission Policy**

Solicitation of business or distribution of materials at the Event by non-exhibitors is strictly prohibited. Violators will be immediately removed from the Event.

Any person found to be registering to attend the Event using false information or credentials or deliberately withholding information will have their application automatically denied and may be liable to prosecution. Without prejudice, the organizers reserve the right to exclude any person(s) from the Event.

Closed Circuit Television Cameras (CCTV) will be in operation at all times during the Event. The organizers reserve the right to deliver the CCTV videotapes to the Police or other competent authority as evidence if requested to do so. The contents of such videotape may be used as evidence in a court of law.

IFAM reserve the rights to film/permit approved third party filming across and throughout the Event.

By attending the Event, visitors permit the organizers/approved third parties to use any footage taken. Any attendees under the age of 18 years, including children of the exhibitors, shall be accompanied by an adult at all times. Canvassing is not permitted.

The organizers reserve the right to exclude or remove anyone from the Event or venue who does not comply with these terms & conditions or who they reasonably consider are likely to break the rules.

### **Badge Scanning**

On arrival at the Event, your ticket will be scanned and you will be provided with a badge.

Your badge will be scanned at the main entrance to the Event. This scan of your badge is for analytical and health and safety purposes only.

By allowing your badge to be scanned by any exhibitor(s) and/or sponsor(s) at the Event, you will be providing access to such exhibitor(s) and/or sponsor(s) to your name and to the contact information which you provided during registration for the show. If you do not want your details to be accessed by exhibitors or sponsors, you should refrain from allowing them to scan your badge.

### **Cancellations & Force Majeure**

Cancellations made within 24 hours of completed registration form will be eligible for a full refund. After 24 hours, tickets are non-refundable.

If your ticket is cancelled due to malpractice or misuse of discounts no refund will be issued.

In the case of an unexpected incident act of god event, and/or force majeure IFAM reserves the right to make changes to the dates and times of all parts of the Event, to re-schedule, or to cancel the Event. If the Event is rescheduled your event ticket will be transferred over to the rescheduled dates and if an Event is cancelled your ticket shall be transferred to the following year's Event.

IFAM is not responsible for any expenditure, loss or damage of any kind incurred as a result of any re-schedule, substitution, alteration, cancellation or postponement of an Event.

### **Discounts & Codes**

Discount codes cannot be combined with any other offers or credit received from a previous Event. Any credit issued must be used by the original recipient and cannot be transferred.

Discounts cannot be retroactively applied to a completed ticket purchase.

Early bird pricing windows are final unless otherwise adjusted by an active promotion. After the pricing window has closed, the expired rate will no longer be made available and cannot be retroactively applied.

If an attendee is found using a discount code that was not provided for the code's intended use, the purchaser's ticket will be cancelled and no refund will be issued.

Tickets and add-ons are subject to individual promotions and cannot be combined or redeemed against one another.

Any discount provided for these add-ons will not be applicable after a purchase transaction has been completed. Discounts must be applied before purchase confirmation when selecting available products.

Tickets distributed as part of a sponsorship package are applicable exclusively to the contracted company. Complimentary tickets will only be valid for said company unless otherwise specified by a member of the IFA team.

Discount codes cannot be redeemed onsite at the event.

### **Live Events**

The events, information, and speakers listed on our Sites are subject to change without notification.

Unused tickets/passes will be forfeited and are not transferable to another event.

Ticket holders may not sell, offer for sale, offer at auctions, resell, donate, act as commercial agent for another party or otherwise transfer their tickets other than in compliance with these terms & conditions. Please note that the tickets purchased are for your own personal use or that of your business only and may not be resold or transferred for commercial gain. Where there has been any resale or attempted resale of any tickets for commercial gain (or any other breach of this term), IFAM reserves the right to cancel the relevant tickets with immediate effect and without refund.

### **Ticket Transfers**

If you are unable to attend the Event you are permitted to transfer your ticket to a third party. You can transfer your ticket to a third party by using the link that is provided in the confirmation email to log into the registration platform and assign the ticket.

### **Ticket Resales**

If you cannot use all of the tickets that you have purchased, it may be possible, at IFAM's discretion, to re-allocate the tickets you no longer want to the next year's Event. If you would like to request the re-allocation of any tickets you no longer want to the next year's

There is no guarantee that tickets will be re-allocated. If your tickets are not re-allocated, no amount will be refunded.
